## THE UASIN GISHU COUNTY EDUCATION REVOLVING FUND AMENDMENT BILL (BILL NO. 14) 2016

### (Second Reading)

**Mr. Speaker:** Honourable Members, this Bill had been introduced to the House. of course, it is coming for the second reading and it is a Bill that is urgently needed. The amendments proposed are urgently needed therefore we have brought it as a House business committee then you can deal with it once and for all to enable the relevant legislation to be acted upon. **MCA Sang**: Thank you, Mr Speaker Sir. I stand on behalf of the Chair on the Early Childhood Education and Vocational Training.

I beg to move that Uasin Gishu County Education Revolving Fund Amendment Bill (Bill No.14) 2016 be now read on the second time. The Bill on education was passed in this House on 7<sup>th</sup> March 2014, that is Bill No.14. The same Bill is on education and issues of bursaries and upon receiving all the reports from the Controller of Budget (COB) through the CEC education, the same was forwarded to the County Assembly for amendments. The County Assembly received the document and forwarded it to the committee on education and now we have a report from education department with amendments and the advisory from COB is that the members of County Assembly be removed so that it can do the oversight role. On Section 8 it is amended by incorporating an officer from education, which is the Report from the Committee. Again on the said Report, Section 14 is amended including Persons Living with Disabilities (PWDs) in the ward committee and also including the County Executive Committee Member for Education, Culture, Youth Affairs and Social Services and Sports. The amendments here is that the name of the MCA which was included in the first Bill is hereby amended as required from the advisory COB and CEC, Education .With those many remarks, I beg to move and call upon Honourable Sing'oei to second the Motion.

The Uasin Gishu County Education Revolving Fund Amendment Bill (Bill No. 14) 2016

### (Third Reading)

Mr. Speaker: Mover, you may now move.

**MCA Sang:** Thank you, Mr Speaker Sir. I beg now to move that Uasin Gishu County Education Revolving Fund Amendment Bill, (Bill No.14) 2016 be now read for the third time.

I want to take this opportunity to thank the COB for his advisory to Uasin Gishu Education fund so that the principle Act which was passed on  $7^{\text{th}}$  July 2014 is hereby proposed to be amended to give effect to the separation of powers and the members of assembly whose main role is oversight. So the amendment here is that we have separation of powers whereby the function of the Executive and the function of the Assembly are hereby so that we have separation of powers.

I want to thank the controller of budget for giving us this advisory and the CEC for the amendments proposed here. I also want to thank the committee of Education for the good work that they have done and the county assembly in general for passing this amendment so that we can have separation of powers in discharge of our core mandate with the executive. Lastly, I want to thank the House for the amendments we have had today and I want to believe the work between assembly and the executive will run smoothly and the issues of bursaries whereby people with disabilities will also be included in the management of this bursaries and beneficiaries are the people of Uasin Gishu. Thank you, Mr Speaker Sir.

Mr. Speaker: Seconder.

MCA Sang: Thank you, Mr Speaker. I hereby call Honourable Sing'oei to Second the Bill.

Mr. Speaker: Thank you. Honourable Sing'oei.

**MCA Sing'oei**: Mr. Speaker, I also rise to second this Motion in form of amendments to a Bill that was passed in this House. Some of the issues that we acquired early on trying to include legislators in the implementation of what the Executive is supposed to do are just coming back to us and I am glad that we are able to realise the position that we belong, that, is oversight. I think this is also in line with our Acts or Bills within the Constitution so that we create ample room for the executive to execute and the legislators to legislate and to do their oversight role. I stand to support. Thank you.

I want to say that the Uasin Gishu County Education Revolving Fund Bill will enable the issues like bursaries and even TIVET to run smoothly.
